Driving Directions:

Southbound:

- Interstate 5 south to exit 175 (145th Street)
- Turn left at 145th Street and follow until Lake City Way
- Turn right onto Lake City Way (follow for .5 miles)
- Turn left onto 125th Street (Bartell's Drug Store is on the right)
- Follow 125th which turns into Sand Point Way NE for about .3 miles until 120th Ave NE

My office is at the corner of 120th Ave NE and Sand Point Way NE on the left (McIntyre Organs Sign)

Northbound:

- Interstate 5 north to exit 171 toward Bothell, Lake City Way
- Follow about 2 miles until 125th Street
- Turn right on 125th Street which turns into Sand Point Way
- Follow Sand Point Way NE for about .3 miles until 120th Ave NE

My office is at the corner of 120th Ave NE and Sand Point Way NE on the left (McIntyre Organs Sign)
